

Cellum's expansion in Asia reaches major milestone *Singapore-based APAC subsidiary to strengthen regional operations*

Singapore, May 27, 2015 – Headquartered in Singapore, a new regional center has been set up by Cellum to oversee the company's operations in East Asia. Cellum Asia Pacific will also be responsible for coordinating expansion in the region.
